

With 16 years of experience in the Residential & Commertcial Real Estate & Property Technology is constantly evolving, and the way our member's receive information evolves alongside it.


By utilizing all digital communication channels to promote transparency and communication LVR will be able to reach more of it's membership and encourage it's members to engage and provide feedback.




How do you feel that LVR can be more responsive to its Members?


How do you feel that LVR can be more responsive to its Members?
