How do I complete this document?

Internet Service Provider (ISP) and Internet Speed Mbps:

On the top of this disclosure, the ISP and speed in which you subscribe are asked here. The main ISP in Southern NV are Cox Communications and CenturyLink. The speed you are currently billed for, will be listed in Mbps, typical smart homes will have at least 100 Mbps, to as much as 980Mbps (1 Gig). The reason is to provide the buyer an understanding of what your home is capable of with the smart devices currently connected on the network. The rationale: a buyer could subscribe to services from an ISP that is less capable than the network capability that you subscribe to, meaning there could be connectivity issues, buffering and/or devices not functioning properly.

Category and Item/Description:

Room / Area / Location:

Since there could be several smart devices of its kind in various places throughout the home, it is important to disclose where the device(s) are as 1 device could be missed and its function may have importance to the household. <u>Please</u> identify where this device is placed. Make / Model:

Smart devices have an identity, like cars do, and the device seen by a buyer who made an offer to the home would expect that same device to remain, if conveyed. Every smart device will "tell" you what it is within the settings or about me so that it can be properly identified. For example, if a buyer sees a RING® doorbell during the initial showing and then upon closing sees a SkyBell®, the buyer would have claim to dispute with the seller. <u>Please list the brand and/or model.</u>

Quantity:

Should there be multiple devices like smart switches, please identify the quantity.

Which APP enabled?:

Operating systems, like Android and iOS may have different names for the application from their "store" to purchase/download the APP from. <u>Please identify the application name in which you use to control this device</u>.

On Wi-Fi Network:

Will it Stay?:

It is very important to clarify your intention to remove fixtures that are attached to the home. Just like a ceiling fan or window shutters are also called real property, so is a device that is attached and connected to the home. A consideration to a buyer's offer could be based on the capability of the smart home devices within and the removal of the devices may have an impact on the decision to purchase your home. <u>Please identify Y for yes, or N for no.</u>
